# Tourism industry close to long-sought goal: pushing back school start dates

The first day of school could come little later next year under a bill awaiting the governor's signature this summer.

In an effort to give the tourism industry a few more August days to make money, lawmakers approved a measure championed by Rep. Jeff Knight, R-Lebanon, last month that would bar school districts from starting more than 14 days before Labor Day.

Currently, local school boards are allowed to set their own start dates.

In floor debate, Knight promoted the idea he ultimately tacked onto a larger education policy bill as a lifeline for businesses that have suffered in recent years as districts have moved their start dates earlier and earlier in August.

"The revenue that is being lost is significant," he told colleagues.

In interviews this week, supporters of the measure backed him up.

Brad Thomas, general manager at Branson-area Silver Dollar City, said that 20 years ago, "the first, second and third weeks in August were significant tourism weeks in Missouri."

But he said changes in the law allowing school boards to move start dates earlier in August have led to tens of thousands fewer visitors to the theme park each year.

Michelle Lambeth, executive director of the Missouri Canoe and Floaters Association, said the changes have also made business difficult for the outfitters she represents.

She conceded her clients were also dealing with other obstacles, like the flooding in recent years, and the change wouldn't add any more days to the summer as a whole.

But she said adding a few off days in August would be a big help to the floating industry.

"Typically when schools let out in the middle of May, our rivers are either flooded or the weather is rainy, she said. "By shifting the school start date later, it will gain the outfitters a week to 2 weeks of being able to fully operate their business."

### Legislation

- \*House Bill 604, an Omnibus Education Bill (Henderson, R-Bonne Terre), contained an amendment of House Bill 161 (Knight, R-Lebanon) which states that a school may start no earlier than 14 days prior to Labor Day.
- Intent was to give the tourism industry a few more August days to make money.
  - "Typically when schools let out in the middle of May, our rivers are either flooded or the weather is rainy...'By shifting the school start date later, it will gain the outfitters a week to 2 weeks of being able to fully operate their business."

- The range of available weekdays from 14 before Labor Day to Christmas Eve is from 88-92.
- The weekdays count does not take out any holidays such as Thanksgiving.

The difference between fourteen days before the first Monday and Memorial Day is 40 weeks/200 weekdays.

- The first year, 2020, has the latest possible first Monday in September, which means there will be the fewest amount of weekdays at 88 days.
- The earliest first day will always be a Monday.

<ul> <li>Earliest start day will always be on a Monday. However, few districts start on a Monday.</li> <li>Range in the number of 88-92 available days before Christmas, depending on the year.</li> <li>The first year, 2020, has the latest possible first Monday in September, which means there will be the fewest amount of weekdays (88) before Christmas.</li> <li>Forty weeks/200 weekdays between the first Monday fourteen days before Labor Day and Memorial Day.</li> </ul>	<ul> <li>Most districts were out before Memorial Day with their current calendar.</li> <li>Most districts would not be out before Memorial Day with the simple adjustments shown.</li> <li>There is variation as to the impact at the local level. A general rule appears to be that the earlier you start the larger the potential for impact.</li> <li>There are additional considerations for a calendar beyond the first and last days.</li> <li>Will there be implications for graduations as more districts are compressed into a smaller window?</li> <li>Required hours versus days presents an opportunity as well.</li> </ul>



### Statement on the Legislation

- \*The legislation doesn't change the required number of hours nor does it specify when school must be out by, thus the time parameters on a school calendar remain in effect and there is essentially the same amount of time for Missouri students to travel or work in the summer in Missouri.
- \*It appears the effect of the legislation will be to trade time from the start of the summer to the end of the summer.
  - Generally speaking, students were out before Memorial Day and could theoretically travel or work in Missouri starting then, but were back in school in early to mid to late-August.
  - Now students will not be in school until mid to late-August, but will be in school after Memorial Day. Thus, there should be fewer students traveling around Memorial Day as they will still be in school the following week(s).



Both models have 40 weeks in session and 12 weeks out.
